

BLM'S PLANNING 2.0 RULE

H.J. Res 44, introduced by Rep. Liz Cheney (R-WY-AL), disapproves of the Bureau of Land Management's (BLM) Resource Management Planning Rule, also known as Planning 2.0. The rule has far-reaching impacts for all future BLM Resource Management Plans and will fundamentally change the way the agency manages all of its land and resources.

Planning 2.0 dilutes local and state input into land management decisions, further centralizes power with bureaucrats in Washington, D.C., and opens the door to allow radical environmental groups to insert their agenda into critical Resource Management Plans. The rule emphasizes landscape-scale approaches to planning, shifting important decision-making authorities from local communities and their BLM officials to Washington, D.C. Despite participating in the rulemaking process, input from states and counties went largely ignored by the BLM in their finalized rule. Oppose this midnight regulation, issued in the waning weeks of the Obama administration, and support a CRA to return power to the local communities most affected by federal land management decisions.
